## Niagara County Sheriff's Dept, et al.

- An officer was sent to my mother's residence, which she shares with my brother, sister and her children on the same day (02-15-19) Judge DeLabio granted Peter Diarbakerly SOLE custody of both children. Officer, Nick Faso rang the door bell and pounded on the door incessantly in the dark hours of the evening without identifying himself or the reason he was there. My totally disabled mother was home alone and petrified. My mother called me crying, her voice was noticeably trembling. She was absolutely stunned by the terrorization of this officer and his unprofessional and inappropriate behavior in her quiet suburban neighborhood.
- I called the Niagara County Sheriff's Dept, seeking further information into why and how my brother was arrested. Officer Nick Faso returned my phone call and from the start, I heard a combative tone from him. He started interrogating me about my sister Katie's whereabouts. Mr. Faso stated to me two separate times during our conversation that "Peter is in town and he's coming to your house". I asked him how he had knowledge of this and why he would share this information with me. Additionally, I asked why he told me this in a deliberately assertive way. I could only surmise that it was Mr. Faso's intention to instill fear in me. And, if I didn't cooperate, there would be consequences from my sister's abuser.
- It is my true belief that my brother was arrested because he did NOT give Officer Faso the information that he was seeking. Furthermore, by arresting my brother, Mr. Faso gained access to my brother's cell phone and car. (Please see Kevin Riford's account of his encounter with Mr. Faso and his subsequent arrest attached).
- Three Niagara County Sheriff's officers in three separate cars came each and every time to my mother's house to interrogate my family about my sister's whereabouts. At times, there were unmarked cars, parked in front of the neighbor's house and they would ring the door bell and stand in the corner of the porch to be out of plain sight when the door was opened by my brother.
- Please see the video on the provided flash drive, where five men (4 NCS officers and 1 US Marshall) show up on my mother's porch to intimidate and instill fear in my family.
   There were several days, where multiple attempts were made on the same day by three or more officers and detectives each time and every time.
- It took a total of nineteen days to arraign my brother on a completely false charge by Mr. Faso. What happened to my brother's right to a speedy trial? The officer neglected to

supply a supporting deposition, which my brother had previously requested. The original court date was oddly canceled for everyone that evening. A sign was posted on the main doors of the Wheatfield courthouse with no reason as to why court was canceled and with no advance notification given to any of the individuals who were summoned there that evening.

- Judge Stenkowski filled Judge DeLabio's previously held position as Wheatfield Town
  Justice when she took over as Lockport Family Court Judge in January 2018. Judge
  Stenkowski made a few odd comments to my brother during the arraignment, such as
  "You might want to hire an attorney, instead of acting as your own". Please keep in mind
  that the ticket was for a violation equivalent to a parking ticket, NOT a misdemeanor or
  felony.
- Please note that all of my family members are law abiding US citizens with no criminal record. There was absolutely no reason for an outrageously harsh response by these various officers and investigators other than to repeatedly and intentionally harass my family.
- If my sister committed a crime and if NCS Dept is being truthful that they actually do have an arrest warrant for my sister, Katie, then why haven't they issued an 'Amber Alert'? If they are genuinely concerned about sister's welfare and that of her children, then why wouldn't they seek the media and public's assistance in finding her? The NCS Dept utilizes private social networks, such as Nextdoor and Facebook to post suspicious activities and missing persons, etc. I've been following regularly and have NOT seen any posts regarding my sister and her children.
- Although I am extremely grateful for Brian Burn's (a FBI agent from the Buffalo field office) help in calling the SCJC directly regarding my sister's case, I can't help but feel that he could have done more. I do know that when an out-of-state resident crosses state lines to threaten, harass, and stalk, it is considered a federal crime. My family and I went to him several times to explain our situation and to seek a federal order of protection.
- Mr. Burns, my brother, sister and I had countless meetings regarding various aspects of
  my sister's case. Each time, I would leave dazed and confused as to how Mr. Burns could
  NOT find anything criminal in this situation. His area of expertise is public corruption
  and his only response a majority of the time was "This is just so bizarre" and "It's not
  what you know, it's what you can prove".
- My brother, sister and I spoke to and filed reports with countless persons from numerous agencies, including, but not limited to the FBI (Buffalo Field Office); Erie County

Sheriff's Department (Domestic Violence Unit); the Niagara County Sheriff's Dept., the Amherst Police Dept.; the Cheektowaga Police Dept.; the Buffalo Police Dept.; the Family Justice Center (Erie County); the Family Violence and Women's Rights Law Clinic (Judith Olin, Esq.). After reviewing all of our information/evidence, NOT one person offered to HELP my sister and her children - NO order of protection granted, even as a temporary measure; NO legal counsel/aid protecting a domestic violence victim and her two young children; NO criminal/CPS investigations properly and thoroughly conducted. NOT one person felt morally and ethically compelled to help my sister and her children!!!

• I knew we were in trouble when I went to a prominent and experienced family law firm, which came highly recommended by a family friend. I decided I would seek non-parent custody of my niece and nephew until the SCJC concluded its findings and a possible criminal investigation could be launched to look more deeply into this matter and their response after hearing the facts of the case and the players involved resulted in a, "Sorry, we can't help you at this time". It was at this very moment when my heart and the world as I knew it, SHATTERED into a million pieces. I can't even HELP my own sister fight this BEAST she is up against!!!

I did find it interesting that during my consultation, the lawyer asked me which therapeutic center was utilized for hosting supervised visits with the biological father and children. I quickly noted that the Diarbakerly family secretively and privately hired and paid an 'unlicensed social worker' who is a family friend to supervise visits and write blatantly bias and defamatory reports about my sister.

The lawyer seemed shocked that the court would allow a man who required supervision to roam freely around town with two children even if accompanied by a "supervisor/social worker". I stated that it was my sister's desire and specific request from the beginning for the utilization of a monitored therapeutic setting to ensure her children's safety and possibly promote the establishment of a bond between the children and their father.

KEVIN RIFORD'S ACCOUNT

On February 15<sup>th</sup>, 2019, I was at my sister's house in Kenmore, NY, getting ready to watch a UB bulls basketball game with my brother-in-law in the evening. About 10 minutes after arriving, I received a frantic phone call from my mother who was at home, roughly 30 minutes away. It was a call like I've never heard from anyone in my life, let alone my mother. She told me someone is knocking on the door very hard and they won't stop in the most terrified voice I have ever heard from my mom. I told her to hide in a safe spot and I would call the police and be there as soon as I could. I hopped in my car and called the police. The police dispatcher asked me what my emergency and where was the emergency. They then transferred me to another dispatcher, I am assuming the town where me and my mom reside, in Wheatfield. The second dispatcher then asked what my emergency was, and I stated the above previously described. The police dispatcher then asked who I was. Initially I wanted to remain anonymous, but then I believe I gave my name, at which time he told me it was a police officer at our residence. The phone call ended, and I headed in the direction of my home. I was in front of Wegmans, on the Niagara Falls Blvd, located in Amherst, NY and received a phone call from a local area number, 716-438-3450. Not knowing who it was I picked up the phone. They asked me if I was Katie's brother. I stated I would not identify myself, until I knew who it was. They then told me they were with the sheriff's department and he was at my house in a irritated and rude voice. He asked me why I did not answer the door if I was inside, again in an irritated voice. I responded I was not even home and that he shouldn't be making false accusations. He told me I needed to meet him at my residence, which I then stated I was at Colton RV, on the Niagara Falls Blvd, approximately 4 minutes from my house and I would meet there. I told him I didn't want a scene at the house. He told me that I don't call the shots in a loud voice, and then proceeded to hang up on me. I headed home and came around the corner where his car was running with visible exhaust vapor coming up with the rear lights lit up on his car. He then proceeded to drive away from the front of my house. I thought it would be a good idea to try to talk from him from his cruiser, away from the house, preferably down the street. I had followed him for roughly 4 minutes, at which point we both ended up on Kruger road, a two-lane road, with traffic going both ways. At this point he was ahead of me in the right lane, headed back towards the direction of my house, at which time he makes an abrupt U-turn, and is now facing my car. I roll down my window and wave my hand at his cruiser, at which time his window comes down with his cruisers spot light blinding my face. I stated I was Kevin Riford and asked him if he waned to talk. The officer then stated only if you want to cooperate this time. I drove up to a stop sign at Mavis and took a left down the road and pulled immediately to the right side. He followed me and then turned his cruisers light bar on, which flashed blue, red, and white light. He proceeds to get out of the car and came up the window. I had one of my hands on the steering wheel and the other visible resting on the door with the window fully down. I asked him what was going on, which he stated vengefully, Delabio gave Peter full custody today. I then stated we already knew that was going to happen. He seemed a little shocked at my response, perhaps even irritated. He then asked me where Katie was. I told him I did not know, and that she went into hiding. He told me lying was a crime. I stated it said she went into hiding on the papers I served to two attorneys earlier in the day. He asked me, which attorneys did I serve and what did I serve them. I told him, that I served both Jason Cafarella and Randy Margulis's law office both affidavits. During this conversation, he continued to look into my car with his flashlight from the outside of the vehicle. I told him I didn't have any rocket launcher, guns, or knives inside. He continued to ask me questions, at which point I noticed at least one, possibly two police officers come to the right side of my vehicle, with flash lights now looking into the inside of my car, as the officer who was questioning me already did. At this point I start to feel uncomfortable and ask the officer if I am being detained, or free to go. I noticed he

looked over to officer to his right and his lips trembled in disbelieve that I had just asked that. He stated I was being detained. I asked for what and he could not give me an answer. I asked him a second time and received the same response. I then told him I would like a lawyer, at which point he asked me to call my attorney. I stated to him, there was no attorney I could call this late in the evening. He then proceeded to walk away from my car and went to talk to one of the officers behind my vehicle. I rolled up the window and called my sister to explain the situation. He came back quickly and started to knock on my rolled-up window at which point I told my sister I needed to go, and I rolled my window down. I then asked for the third time, if I was being detained or if I was free to go. He stated I was being detained, however, this time when I asked for what, he said for harassment, and that I was following him in a public place. He asked me why I was following him. I stated that he had called me on my cell phone to talk to me, he was in front of my house and I decided to talk to him, which he replied I should have called the non-emergency number if I wanted to talk to him. He stated he saw that I've called the non-emergency number before, so I should know how to do that. I asked him if he was serious, and he told me to get out of my car, which I did. He told me to put my hands behind my back, which I again did. When I had my hands behind my back and my wrists together to get cuffed, he then placed his hands on my wrist and told me to stop resisting, even though no such resisting had occurred. I was relaxed as a cucumber, as I knew I had committed no crime nor violation. I am sure his dash camera and body camera will show this. He then placed me in the back of his patrol car and got in the front of his vehicle. I asked him what I needed to do to not be arrested, which he stated it was to late. I was unsure of what it was too late for, as I did nothing wrong. Soon after, he told me that Peter Diarbakerly was going to go over my sisters house Christina. I wasn't sure what to make of this, and to be honest I was shocked and scared for my sister and brother in laws safety. I then asked him if I could have my cell phone from my vehicle that was in my cup holder and he stated he didn't know where it was, even though I had just told him. My car was left running with the keys in the ignition and cell phone inside. He said my car was going to be towed, and he took me to the holding station. On the way to the station I feared for my safety, as he was the only one in the patrol car. He told me I was well dressed and had great communication skills. He stated that I watch too many police YouTube videos, which I stated I do not watch YouTube, but have taken some law classes. He also asked the question, why are you even involved in this, it has nothing to do with you. I was perplexed and why he would say I had great communication skills, yet I was in handcuffs. Fearing for my safety, I tried to make small talk with him in the car. I asked him if he had wife and kids, at which point he said he did. Quickly after his statement, he said well I did. I asked him what happened, which he replied they died in a car crash. At this point I felt like my sister and brother in laws safety was in danger, however, I could not do anything. I was charged a \$100 bail fee at jail the same night and had to pay close to \$300 in towing fees the next day to get my car back. All-in-all I was charged \$400 for wanting to talk to the police officer who CALLED MY PHONE asking to talk to me in person. My rights were never read to me, or even implied to me. I have no doubt in my mind this was a personal arrest, done through Ms. Delabio for my family having her under Judicial review. I had no intention of alarming, harassing or annoying the officer. He was the one who called me. Not the other way around. I have nothing to hide, and would like all police video footage to be released. I have a feeling the video will be found to not have been running constantly, and parts omitted.





"With your help, Niagara Falls can expect a dedicated, hard-working judge that will be fair yet firm, understanding the needs of our community," Faso said.



## Town of Wheatfield: Cliffe will not run for re-election

Town of Wheatfield Supervisor Robert B. Cliffe has announced he will not seek re-election this November

their energy and ideas to this critical position. I'm a strong believer in term limits; I include myself in this concept." "I have been planning this since 2009 when I first ran," Cliffe said. "My goal was to have two four-year terms. I was not able to change to four-year terms, but after eight years, it is time for someone else to bring

Cliffe said the Town Board members and department heads have worked together to accomplish "a great deal" since he took on the position of supervisor

He said the "critical component was getting a handle on finances, and we have done that.

Improvements to Fairmount Park, including the recent installation of handicapped-accessible pathways and new restrooms, were completed, as well

Cliffe also said "substantial strides" have been made in the town's recreation programs

He added, "We've done several major infrastructure repairs and improvements, and passed the Local Waterfront Revitalization Plan, the comprehensive plan, the farm protection plan and a new solar law, and so

Also several drainage improvements were made throughout the town

However, there is more to be done, Cliffe said

"We have to continue with maintenance, and we also need to keep looking for improvements in troubled areas," he said

Looking to the future, Cliffe said some of the challenges his successor will face are seeing through the "final disposition" of the Niagara Sanitation Landfill, including the completion of the fence around the site.

"Of course, the main work is being done by DEC, but the town will continue to be involved," he said

Cliffe also said the challenge of how to install Wheatfield's portion of the proposed Greenway Trail bike path will be something to be worked on in the future.

## **CPS**

- CPS has taken "hands-off" approach throughout my sister's case despite credible evidence to suggest that their involvement was essential in seeking more information in protecting the well-being of Katie's two minor children.
- CPS Kelly Custode informed me and Katie that Randy Margulis, Peter's attorney and Jason Cafarella, Attorney for Children (AFC) called CPS directly to state that there was no way neglect/abuse could have occurred during supervised visitations because a licensed clinical social worker was present at each visit with Peter and his family. Why would an Attorney for Children intervene with getting to the bottom of child abuse and neglect affecting his own clients?
- Eric, a caseworker from CPS assigned to a current open CPS investigation recently called and told me that Peter had an order of protection against Katie for her daughter. How would Eric know this information before we did? Later that day, there were a total of four Niagara County Sheriff's investigators who came to the door and Brett Thompson stated they had a warrant for Katie's arrest and asked if my mom wanted a copy of it and my mom said yes. He then stated he had to go back to the car and get it. He handed her the paper and when she reviewed it later after they had left, she noticed it was an order of protection she was handed and NOT a warrant for her arrest as he originally stated.

My mom asked Brett how Peter was able to get an order of protection when her own daughter couldn't even get one. My mom said after she asked, Brett's mouth dropped in shock and he asked how she knew that Peter had an order of protection. My mom proceeded to tell him that Eric from CPS had told her daughter, Christina, earlier that day.

There were several neighbors who witnessed these various public displays of intimidation by the Niagara County Sheriff's Department.
