

## **The Diarbakerly Family**

- The biological father, Peter Diabakerly submitted two tax returns for child support calculation purposes, showing he claimed the oldest child as a dependent. The oldest child NEVER lived in Lincoln, MA at any time or visited without her biological mother present. The youngest child has NEVER even visited the residence of Peter and his family. Peter has always lived with his parents in their home with one exception, which was living in a dormitory while attending school.
- According to the IRS, a child can only be claimed as a dependent if he/she lives with the parent fifty percent of the year. It is likely that Peter has claimed the oldest child as a dependent since birth based on the two tax returns revealed to the court. My sister was NEVER informed by Peter of his decision to claim her children as dependents.
- Peter works for his father's business and has been covered by health insurance provided by that same company. If Peter cared even the slightest bit about these children, wouldn't he have at the very least, added them to his health insurance plan instead of having them be on Medicaid, which my sister was forced to use because she never received consistent child support to aid in meeting the needs of her children.
- Peter and his family were given a special private room to sit in while waiting for court to commence while my sister and all other individuals ('commoners' as the Diabakerlys refer to the average American) utilized the public waiting room at the Lockport Family Court.
- Peter only listed the oldest child in his initial petition for custody, not the youngest. He never denied paternity of the youngest. The judge threw the youngest child in as an afterthought.
- The initial petition for custody was filed on my sister's birthday – 11/15/17. The choice of this exact date was personal, deliberate, and an obvious act of vengeance by his mother toward my sister. His mother wanted my sister to pay for what she perceived as her son's life being ruined.
- Peter and his family NEVER told his extended family he had a child until the oldest child was five years old. Additionally, his friends did NOT know he was a father, as well.
- Most of Peter's family HATED my sister. My sister went on one trip with Peter and his family toward the end of their tumultuous relationship. It was a trip to Quebec, Canada during the coldest time of the year. My sister was supposed to go skiing with Peter and his family, but Peter forgot to wear a jacket on a freezing cold day. Peter's sister posted a cryptic message on Instagram revealing that fact and confirming my suspicion. I believe his family planned to kill her that day by making it look like a skiing accident, but Peter chickened out and foiled that plan by intentionally forgetting his jacket.

- Peter's mother verbally abused my sister and encouraged Peter to abuse her throughout the course of their relationship. Peter's mother, Regina told Katie her second child was "one too many". Regina called Katie profane names on numerous occasions at her residence.
- I had to call Peter's mother during Katie's first pregnancy to tell her to STOP her son from repeatedly pressuring my sister to abort her pregnancy. She said to me that she didn't control her son, but after that conversation there was no further harassment with regard to aborting the pregnancy.
- Peter told Katie if she left him, he would take her to court and get custody of her baby. He forced her to hyphenate her daughter's name right after giving birth, which she did not want to do. My sister felt weak and scared because he cornered her alone in the hospital room.
- Peter told Katie on numerous occasions that "when you have money, you can get away with anything". I told her to not believe Peter's lies, but now I think I was wrong because the situation played out exactly the way his family intended it to.
- Peter worked hard to distance Katie from her family and friends. The outgoing young woman with a promising future who I once knew seemed to vanish before my eyes.
- Peter verbally, physically, psychologically, sexually and financially abused my sister for years and she never confessed or confided her horrific ordeal to any one person. She felt paralyzed to leave because she was tormented by his constant and consistent threats to punish her and her children.
- My sister met Peter during at an extremely vulnerable time in her life. Our dad had died suddenly and unexpectedly at the age of 53. My sister was shocked and devastated by this monumental event during her college years. She made a poor choice in dating Peter, but never regretted for one second choosing to go forward with both unplanned pregnancies.
- My sister Katie recently shared stories with me that Peter's younger brother told of abuse that they endured over the years. The mother and father throwing red pepper flakes in their eyes, physical altercations between the children and their father, requiring repairs to drywall, etc.
- My sister went into hiding because she trusted her intuition that if she didn't run, she would NEVER see her children again. More importantly, she KNEW without question that her children would likely face an ill-fated future, especially if she wasn't there to protect them.
- With all of the incriminating texts and emails from Peter to Katie, declaring self-harm/suicidal ideation, death threats, verbal and sexual abuse – NOT one person



intervened to hold the abuser accountable and offer help to his victims.....As a registered nurse, I find this utterly baffling and unacceptable.

- Peter has strongly demonstrated mental instability in countless documented communications with my sister, Katie. Not ONCE was he offered or DEMANDED to go to counseling for his mental health issues.....SHOCKING!!!
- My sister was under Peter's total control until her second pregnancy. At this point, my sister knew she couldn't stay in this abusive relationship because Peter had yet again pressured her to abort the second pregnancy, even using his own daughter as a pawn to encourage Katie to do what he wanted. I took this opportunity to tell my sister that she didn't deserve to be mistreated, abused, and violated. I started to see a glimmer of hope that she understood and accepted my advice. My sister made the decision to leave the relationship and shortly after lost COMPLETE custody of her two minor and defenseless children to a family of monsters that worked relentlessly to prevent them from ever existing in the first place.
- Peter Diarbakerly perjured himself countless times in court documents, stating blatant lies. One of those lies, Peter claims that I was leaving a parking lot at a high rate of speed at a pick-up/drop-off location, which was at the Amherst Police station. There is camera surveillance throughout the parking lot area, which could easily prove that this did not happen.

In fact, there were numerous occasions when Judge DeLabio said she would subpoena phone records to find out who was lying when it came to Peter and Katie's vastly contrasting accounts of events throughout the court case and her findings were never shared in court. I would actually like to know if Judge DeLabio ever truly did subpoena the phone records.

Dear Counselors:

I am in receipt of Mr. Margulis' email, dated March 25, 2018. The Father has once again falsely accused the Mother of failing to communicate with him to schedule his visitation with the children. It is bizarre that the Father has outright failed to communicate with the Mother in any manner, yet he has falsely reported to his attorney that she will not cooperate with him. It is clear that the Father is attempting to utilize his false allegations as leverage in the pending litigation.

I have attached the parties' text message exchanges regarding the Father's upcoming, monitored visitation with the children. As the text messages clearly demonstrate, the Mother previously promptly responded to the Father and she made every effort to facilitate his access weeks ago. As the text messages demonstrate, the Mother provided the Father with several suggestions regarding dates, times, activities, location, etc. Nevertheless, the Father has made no effort to schedule his visitation since March 15, 2018.

With that being said, the Mother again proposes that the Father have access with the children on Saturday, March 31, 2018 at 1:00 p.m. at a mutually agreed upon location that is suitable for both children, such as a local library, a coffee shop, etc. Once we have received confirmation of the visit, the Mother will ensure that her mother and the children are at the agreed upon location at 1:00 p.m.

Moreover, unfortunately, the Father's inappropriate telephone conversations continue to have a negative affect on Olivia. For instance, Olivia's Principal has advised that she has been acting

aggressively towards her classmates. Olivia has also been having panic attacks at night. And, she wakes up with nightmares.

Specifically, Olivia complains following her telephone calls with the Father that the Father interrogates her during the calls and that he speaks to her in a baby voice. Olivia also stated that the Father asks her incessant questions about the Mother and that this makes her feel uncomfortable.

Finally, I note that the Father has also withheld financial support from the Mother in an attempt to further control the Mother. The Father's actions in this regard will be raised at the hearing of this matter. Thank you.

## **Sexual Abuse**

- Forced to have non-consensual sex and oral sex throughout the entire 9 years, including at times when Olivia was in the same room sleeping. While I knew it was wrong to be forced, I did not know this was considered rape/sexual assault during our relationship. I thought that when you were in a relationship as bf/gf or husband/wife, it would be considered to others/law enforcement as something that you had “signed up for” when you decided to be in a relationship with the other person.
- Forced to send nude pictures or Skype “shows” (Skype show: had to appear on Skype video call naked or in lingerie he purchased for me and show him whatever body parts he wanted to see) to get money for the kids and I. The last Skype show was when I was 9 months pregnant on 9/4/17.
- Entire relationship was like walking on eggshells. Peter was like a “ticking time bomb” and I didn’t know when he was going to explode with anger. One thing that made him happy was anything related to sex.
- Would often remind me of how hard he worked for the kids and I and how I “owed” him for that or for something he did for me/for the kids and in turn, demanded sex, oral sex, nude pictures, Skype shows, etc. “I bought you this, now you can give me this (insert demand for sex, oral sex, Skype show, nude pictures).” Was also guilt-tripped into feeling like I was not providing into his “needs as a man” when I tried getting out of his sexual demands.
- During one of the last times he stayed at our house, he was playing with Olivia (building a tent out of blankets) in her bedroom. After he left our house, Olivia confided with me that her dad asked her to “keep a secret from mom” when they were playing in her bedroom. My mind quickly thought of a horrible situation where she may have been sexual abused, so I instantly asked Olivia if her dad touched her any of her body parts that are considered private and she told me no. I believe that when Peter asked Olivia to “keep a secret from mom,” he was testing the waters to see if Olivia would be able to keep a secret from me. If she was able to keep a secret, he may have tried to sexually abuse her knowing that he could groom/condition her to not tell me.

## **Physical Abuse**

- When I was pregnant with Olivia, Peter grabbed me by the neck, pushed me against the wall, and began choking me. He also pushed me off a high-rise bed (in his dorm room where the bed was put on risers so a small refrigerator could fit underneath) and I fell to the floor.

- Peter has forcefully restrained Olivia on her bed as a form of punishment. This would traumatize Olivia and she would scream and cry for me until I got to her. I would immediately run to where she was and yell at Peter to get off of her and how wrong punishing a young child in that manner was. He would also restrain me in the same fashion and leave bruises on my body. I would try to fight him off of me, but considering he is much larger than I am, I was never able to get free.

### **Physical/Emotional Abuse**

- During the hospital stay when I had Mason, Peter caused a severe outburst of anger/hostility over my decision to give Mason my last name and I was shoved when I tried to grab the call button to have a nurse come to my room. Olivia was in the room during this time – she ran to the bathroom to grab me tissues and then hid behind me during the remainder of the time. I was able to call my sister, Christina on my cell phone and my sister could hear Peter yelling at me in the background. She immediately called the nurse's station and asked to speak to my nurse. My sister told the nurse she was concerned for my well being, as well as her niece and newborn nephew's well being as well. After the nurse was notified, she immediately came into my room. Peter was asked to leave for a duration of time and after he left, the nurse asked me if I wanted to set up a "code word" for my safety. After the incident, I was discharged the same night, but did not leave the hospital as my son was still in the NICU. I was given a room as a "boarder mom" so I could stay at the hospital with my son. However, after the incident, my son was not allowed to stay in my room and had to stay in the nursery to ensure his safety. All feedings and visiting him had to be done in the nursery with nurses present. My sister came the same night to make sure everything was ok and that I was not being pressured by Peter in regard to the name on the birth certificate. Peter stood by the door of my room the entire time my sister was visiting me. When he sensed her visit was coming to an end, he left and unknown to us at the time, waited in the Labor/Delivery Unit's waiting room. When my sister left my room and walked past the waiting room to leave for home, she was ambushed by Peter. He was extremely hostile and yelled, "So is this how its going to be, Christina?" and tried to convince my sister that I was a horrible person and that if I did X, Y, Z, our relationship could have worked out. Peter was shouting and causing a scene and the nurses in the Labor/Delivery Unit called the hospital's security team to come. After my sister was ambushed, she of course, defended me and told him the negative effect he has had on Olivia and I and that if he did not want to be a part of our lives, he was free to walk away and that she and my family would be more than willing to help support the kids and I in anyway that they could. Immediately after this incident, Peter texted my phone, while I was recovering from having a baby and taking care of a sick baby in the NICU and said, "Your sister is a fucking piece of work and you tell her I said so." He then told Olivia that same evening, "Your Aunt CC is a bad, bad person. Stay

away from her." My sister has had nothing but a wonderful, positive relationship with Olivia and has been there for her from the day she was born. Having to hear her father state such hateful, untrue statements about her Aunt was absolutely devastating to Olivia.

- I tried on many occasions throughout our 9-year relationship to distance myself or outright leave the relationship and was always given some sort of threat by Peter. He has made statements like, "If you don't want to be with me, then we can go to court now." I did not want him to be awarded joint custody/visitation rights at his home since I know how abusive/controlling /emotionally unstable he is and how unstable and emotionally abusive/controlling his family/home life are, so I stayed with him in my efforts to best protect my daughter and her best interests. I would also be manipulated to believe he was going to change if I would give him another chance. A bouquet of flowers sent to the house with a note attached begging to give the relationship another chance for Olivia's sake.

### **Financial Abuse**

- Peter controlled every aspect of money during our relationship. Before Olivia was even born, it began with him asking me to write college assignments and in return, there would be a gift or money. Once Olivia was born, he wouldn't even ask me to write the papers, the assignments were just emailed to me with a deadline and I was expected to write them if I wanted to "earn" some money to help pay for Olivia's needs. He had so much control over me that he would often give me an assignment that was due to next day and I would be up until 3 am, with a newborn, finishing his assignments so I would not upset him. For all four years of his college education, I wrote every single English class assignment. Once he learned he had such control over me with the assignment writing, he knew he could control me in other aspects too.
- Peter gave me physical credit/debit cards of his that were in his name to use for Olivia and my needs. If I ever "disobeyed him," angered him, or we got into an argument, he would cut off access to the credit cards and would make me beg him or make me do something (usually sex related) to "earn" an allowance, which was a set amount of money on his credit card.
- More often than not, a set allowance was given and I had to beg for it. I was asked, "What will you do for me if I give you this money?" or told after I was given money, "I gave you money, now can I get what I want?" and this meant he wanted something sexually (sex, nude pictures, Skype show, etc.).
- Currently, he is not being reliable with money and outright playing games with money as one of the last efforts to have control over the kids and I. He picks \*if\* and \*when\* I will receive money for the kids' needs. When I asked him if it is no longer going to give me money for the kids, he says, I have to ask him for it. By "asking,"

Peter wants me to beg for it and account for every penny spent so he can belittle me on how the money was spent.

- Every cent during our relationship had to be accounted for. I was belittled for every purchase made. "You spent too much." "Why did you buy Olivia clothes? Don't her clothes from last year still fit?" "Where did you go?" "What did you buy?"
- Chose if and when he would provide necessities for Olivia. When she was a baby, it was my family who had to be reliably there to provide diapers, clothing, and other necessities. With Mason, he refused to buy a single thing for him. Only when he filed a petition with the court, is when he started giving diapers.
- Told me that he could not add Olivia onto his health insurance through work because she lived in another state. Yet, he claims her on his tax returns each year to get money for having a child.
- In January 2017, Peter purchased me a car when my car was older and had too many costly repairs to consider keeping/fixing it. Of course, it was "I just bought you a car, what are you going to do/give me/etc?" The wanting something of sexual nature and pressuring me to give it to him would happen monthly after every monthly car payment. Currently, he is making payments late or missing 1-2 months at time after I have been coming forward with the abuse he has subjected me to during our relationship. This is also hurting my credit, so I will be unable to make purchases of my own now and in the future. He wants me to carry stress about the car payments and whether the car will be repossessed or not. He also wants to remind me who is in control of the vehicle, as I cannot otherwise afford the car payments on my own.
- Because I refused to get an abortion with Mason, he began to heavily cut off access to money. Peter would not allow me to purchase diapers, clothes, or any baby necessities needed for the baby before he was born.
- Olivia missed the first week of school because Peter played games and did not want to pay for her tuition on time. Olivia's school required payment before she could attend. This caused a lot of unneeded emotional stress on Olivia and it was very hard for her to adjust into the class when she missed the first week. It was also stressful for me at 9 months pregnant, not knowing what was going to become of Olivia's education.
- Peter has outright refused to file for financial aid to make Olivia's school tuition a more affordable option. He does not want me to know how much income he annually makes (something he has hidden from me during the whole 9 years), which would be required when filling out the financial aid forms and he has wanted to make it seem like she is in control of Olivia's schooling.



- Often told during the relationship, "When you have money, you can get away with anything."
- Have not received any money, clothing, diapers (which he is the one who has to order with my accounts) since January 2018.

### **Emotional Abuse**

- Was often called a bitch or stupid. These names would be used towards me in front of Olivia. "Your mom is such a bitch." "I'm not coming over because your mom is a bitch." "Why is your mom being such a bitch?" etc.
- Peter interferes with the positive relationships that Olivia has with my family. Told Olivia to "stay away from Aunt CC because she is a bad, bad person" and then texted me and said, "Your sister is a fucking piece of work and you tell I her I said so." Regularly referred to Olivia's maternal grandmother and uncle as "Tweedle Dee and Dumb" directly to Olivia and I.
- Peter told me, "I know you love me, because after everything I have put you through, you're still here."
- When I was pregnant with Olivia, Peter asked me to come be with him at his college because he was emotionally unstable (because of my pregnancy). This is where he put his hands on me for the first time (choking, shoving against the wall, and pushing off the bed). When Peter refused to tell his parents about my pregnancy, I knew I would have to be the one to do it. Unbeknownst to me, he changed his mother's number in my cell phone to a random one. When I finally figured it out, I was able to get in contact with his sister and asked her to reach out to Peter to discuss something very important. Within minutes, she called Peter and he was forced to tell her that I was pregnant. The next day, his mother and father picked Peter up from his college and brought him to the Panera in town (they did not know I was there with him) and told him that I had to get an abortion. From the minute he came back from the meeting at Panera, the extreme pressure and anger towards me to get an abortion began.
- Heavily pressured me to get an abortion with both Olivia and Mason. With Olivia, I was called a bitch on a daily basis, told that I was destroying him and his life, told that he wanted to kickback the chainsaw he owned and kill himself etc. After it was past the timeframe to legally have an abortion in New York, I was told that I should go to Canada to have the abortion done because he researched that it was legal there later in the pregnancy than here in the U.S. The emotional abuse was so severe with Olivia, my sister had to intervene by calling Peter's mother and asking for her to make Peter stop with the incessant harassment/abuse that was happening every single day. With Mason, he tried a different technique coming straight out and

asking for me to abort him to “help us,” and that we could be a family under the condition that I were to get an abortion. He promised Olivia that she could finally have a family, an apartment or house to live in Boston, and a new school “if mommy does something first.”

- When I was in the hospital having Olivia, Peter sat on the bed where I was filling out the birth certificate and made sure I gave her the last name he and his family decided she should have. Heavily pressured by him when he was sitting there next to me and I was on pain medicine.
- Peter became very hostile towards me when he realized I was going against his demand to get an abortion. He sent me a picture of him crying as a tactic to get me to feel sorry for him and get an abortion. My entire pregnancy I was treated horribly. When I was 8 months pregnant, he sent me a text and said, “The problem is your pregnant.”
- Deliberately hid my pregnancy from his entire family during my entire pregnancy. I was told that I was not allowed to tell my family about my pregnancy, despite him knowing I did not want to. Finally, when I was 5 months pregnant, I knew I could not continue to live a life of lies to my own family whom I am close with and I announced my pregnancy to them. They were very positive, accepting, and loving towards the news of the new baby. On a regular basis, I would ask Peter if he told his family yet and he always said no. Olivia was told that she was not allowed to tell his family about her baby brother/sister and Olivia did not understand why something like this had to be a secret. She struggled a great deal with this. At 8 months pregnant, with the encouragement of my family, I told Peter I could not live my life as a lie, and called his mother. His mother was outraged by the news and said Olivia and I were to stay in Buffalo and not attend the wedding because my pregnancy would “distract the bride.” Peter’s family only cares about their image and did not want their extended family and friends to see that I was pregnant. She told me, “Having one child is one thing. Having another is a whole different story. I will call you after the wedding is over and come up with a plan.” The phone call after the wedding never happened.
- Constantly blamed for everything. For example: When something went wrong, it was my fault. When he didn’t think I listened to his demands, I was blamed and ridiculed. When he felt I was spending “too much of his money,” I was belittled.
- When Olivia and I showed emotions, we were told we were overreacting and wrong for having feelings. If Olivia would cry about something he said or did to her or she witnessed incidents of domestic violence, he would tell her, “Oh, you’re fine. You’re a big girl. You need to stop crying.” If I showed emotions or let him know about my feelings, it was, “get over it,” “you’re fine,” “you’re crazy,” etc. When Olivia witnessed Peter screaming at me when her brother was born, she cried out of fear and for

knowing he was being mean to me. When he saw her crying, he said, "What are you crying for?" with zero attempt to console her.

- Belittled Olivia for food choices and forced her to hide where she ate with us to his family. For example, if we went to a restaurant and ate lunch, she was told by Peter, "Make sure you do not tell Grandpa and Oma that we ate lunch at X restaurant." When she would ask why she had to keep something as ordinary as eating at a restaurant a secret, she was told that it would "make his parents mad and we wouldn't want to upset them" or was told "they don't need to know everywhere we go and everything we do." At the hospital, Olivia was given the opportunity to order a "celebration dinner" with me to celebrate the birth of her brother. The dinner, which was prepared/arranged by the hospital, came with a small piece of cake with whipped cream. When Peter saw the cake on her plate, he removed all of the whipped cream in a mean manner and said, "You don't need this shit." However, the next day, he went to Tim Horton's in the hospital lobby and ordered her a smoothie and donuts to eat. As long as he is the one to personally give it to her, its ok. But any other time, she is made to feel guilty for eating sweets and anything he deems as "unhealthy."
- Started verbal fights with me to get out coming for a visit OR to prevent Olivia and I coming to an event, such as a graduation. Would call up and start a fight out of nowhere saying, "You can't come to my graduation, because you're a bitch."
- Refusing to meet Olivia's medical needs. Peter told me, "Olivia doesn't need counseling. She is fine." Given a hard time about giving her allergy medicine or when she needed her adenoids removed, telling me she didn't need to.
- Suicidal tendencies. Has told me many times that he wants to end his life and how he will do it. I am very concerned that he will end his life AND Olivia's and/or Mason's if he was given time alone with them to give me a life long punishment.

### PETER'S FAMILY

- Peter has been and continues to be strongly controlled by his parents, especially by his mother, Regina.
- When I was pregnant with Olivia, I was not allowed over Peter's home for the entire duration of my pregnancy. Peter's father would not talk to me simply because I was pregnant and would not allow Olivia and I over until she was 2 months old.
- Peter's parents outright hid my pregnancy and Olivia's existence to Peter's uncle and his family, who they see on a regular basis and who live very close by. He also hid Olivia from the rest of the extended family and friends. Peter's Aunt and Uncle

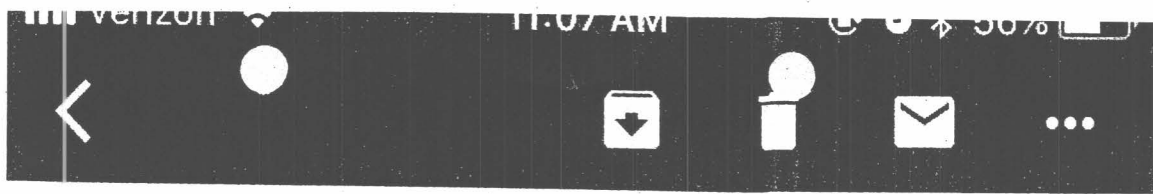
who live very close by to them did not know about Olivia until she was about 5 years old. A picture of Olivia as a baby was hung up on the wall and removed when family came for a visit. Olivia has only met/seen the extended family approximately 3 times and only on Christmas Eve or Day.

- Was only allowed at the house approximately 1 time a year, at Christmas. Once in a while, we would go for a few days during the summer, but it was scheduled for the last few days of Olivia's entire summer vacation. Peter NEVER came here during Olivia's summer vacations from school. Anytime Olivia and I were in Boston other than a "scheduled" Christmas visit, Peter and his family refused to see Olivia. They only cared to have Olivia and I during Christmas because they threw a party at their home which the extended family/friends came to and it was all for show.
- When we did see extended family, our conversations/interactions were extremely monitored by Peter. He would sit next to us to make sure we weren't saying what he deemed to be "too much" and if he felt like we were, we were called into another room of the house where we would be yelled and instructed to not tell them anything because they are "snakes."
- At Peter's house, there are regular physical and verbal fights between family members. Picture frames being thrown from 2<sup>nd</sup> floor of home down the flight of stairs. The walls were punched and left huge holes, which Peter would immediately repair with supplies in the basement. Peter's father would verbally assault Peter's brother, Sam where he would be called "garbage," among other things. Olivia was told that if she did not behave, her grandfather would put pepper in her eyes and her grandmother would hit her with the "hickory stick." When we thought that it was just a joke, Sam told us, "You think I'm joking? That is what happened to us."
- Peter's father (whom he lives with) has a quick temper. During one occasion at the Verizon store, when he did not feel the store was giving him what he demanded, he got his phone, and threw it at the screen inside of the Verizon store.
- Entire family, including Peter is extremely racist and has made their hate for Blacks, Muslims, Jewish people, Gay/Transgender, poor people, etc. Peter separately, and with his family has made jokes and comments in front of Olivia and TO Olivia in regards to their hate for these people. Peter, while driving, would play a game and say, "How many points is this one worth?" while pretending to hit them with the car.
- Bedroom doors were removed from the doorframes for the adult children, with only recently adding them on at our last visit – December 2016. Parents' bedroom was locked with a key.
- Anytime I went to Peter's mother about a concern related to Olivia, she made it known that Peter was not ready/did not want to be a father. She told me that he was not mature; she encouraged me to "walk away" if he was not willing to give Olivia

stability and consistency. When I told her about concerns I had about Olivia's last name, she told me, "It's a done deal." When I told her about concerns I had that Peter worked too much and was never around for Olivia, she told me, "That's what he wants to do. That is what he's going to continue to do. If you don't like it, get lost." She always made excuses for her son and made it known that she did not approve of Peter being a father.

- My parenting skills as a mother were constantly criticized, by his family to make me feel badly. The duration I breastfed Olivia, Olivia being given a pacifier, etc. I was told by his mother often, "None of my children used a pacifier." And her daughters would say on cue, "You should know mom, you did have 5 children after all."
- Peter bragged that he worked 80+ hours a week for his father. He has been in several accidents, with at least one occurring because he fell asleep behind the wheel after working.
- Peter's family has not seen or had any communication with her since seeing her last during Christmas 2016. Has not communicated with me to ask how Olivia is doing.
- Peter's family has not acknowledged Mason's existence since finding out I was pregnant/since he was born on 9/12/17.

**Peter views the children and I as property. He wants custody/visitation for CONTROL and as punishment/revenge because I did not send Olivia to his sister's wedding on her own when I was uninvited.**
